






Charm and Possibility of Yokohama City

 The prospect that increase follows until about 2020.
 - More dominant than the whole country
- Decrease in productive

(Osaka city is the ranking second place) (Cabinet office : Report on prefectural accounts produced (FY2012))




Y-PORT (Yokohama Partnership of Resources and Technologies) Through Public – Private Cooperation


Continuous Childcare Support, and Youth Support for Independence




Situation of the City Duty Income (Comparison with the estimated amount of duty income)




- Reducing administrative costs through the intensive review of city projects


- Benefit from Japanese strong system framework about local government, including financial support and strong monitoring to local finance (Strong system framework supports city finance)
